FSA operates the FANN (Friends and Neighbors Network) program at sponsors' sites so that low-income families have enough food, learn about healthy lifestyles, form uplifting community, and have opportunity for spiritual expression. FSA distributed 215,316 pounds of food to 334 families with low-incomes at 154 meetings in the Greater Atlanta area and Augusta, GA. The 701 family members included 36% children and 18% seniors. We collaborated with the Atlanta Community Food Bank and a farmers' market to provide 10787 pounds of fresh produce

FSA teaches other non-profits and churches to operate their own FANNs. In 2016, we travelled to Little Rock, AR; Columbus, GA; Raleigh, NC; Chattanooga, TN; Harrisonburg, VA; and Richmond, VA to train organizations how to start and run their own FANN programs. FSA collaborated with Urban Recipe in two day-long training sessions in Atlanta..

Food Security for Georgia, a program of FSA, is an association of non-profits and churches formed to uplift best practices, to offer a forum for sharing experiences, and to uphold accountability through peer visits and annual reaffirmation of its principles. FSA facilitated four Food Security for Georgia meetings for over a dozen member organizations, including a motivational brunch for FANN steering committee members from different organizations.
