FSA OPERATES THE FOOD SECURITY GROUP PROGRAM AT SPONSORS' SITES SO THAT LOW-INCOME FAMILIES HAVE ENOUGH FOOD, LEARN ABOUT HEALTHY LIFESTYLES, FORM UPLIFTING COMMUNITY, AND HAVE OPPORTUNITY FOR SPIRITUAL EXPRESSION. IN 2018, FSA DISTRIBUTED 294,641 POUNDS OF FOOD TO 260 FAMILIES AND SENIORS WITH LOW-INCOMES AT 128 MEETINGS IN THE GREATER ATLANTA AREA AND 54 SENIORS WITH LOW INCOME AT 24 MEETINGS IN AUGUSTA, GA. THE 574 FAMILYMEMBERS INCLUDED 37% CHILDREN 17 AND UNDER AND 17% SENIORS WITH LOW INCOMES.
