FSA operates Food Security Groups at sponsor sites so that low-income families have enough food, learn about healthy lifestyles, form up-lifting community, and have opportunity for spiritual expression. From July 1, 2020 to June 30, 2021 FSA distributed 302,061 pounds of food to 564 unique families. Most families received food multiple times, up to twice a month. Of the 1,522 individuals in the families, 594 were children, or 39.9%

**4b** (Code: ) (Expenses \$ 32,445. including grants of \$ 0.) (Revenue \$ 0.)  
The COVID pandemic devastated affiliate programs across the country. By necessity programs turned into emergency food pantries, and some shut down altogether. Even so, affiliates - and the members who formed a community around the need for food - believed so passionately in the dignified way of receiving food that most stayed together. In 2021, 34 organizations in 14 states operated programs that were in various stages of returning to the Food Security Group model. FSA did not train any new affiliates during this time.

Usually FSA networks with similar organizations operating Food Security Groups. However, due to the COVID pandemic, restrictions on travel and the necessity of social distancing, these activities were curtailed.
